I am pleased to present "Foundations for the Future" to you. This very simple first report honors those who have laid the foundation for the successful opening of Cristo Rey Jesuit High School in Baltimore.

Each week the media report the challenges faced by students in schools serving urban communities. At Cristo Rey Jesuit we have designed a program that meets these challenges by combining excellent classroom instruction with meaningful community and business partnerships. We believe that every young person deserves an opportunity. This is our mission, this is our hope.

Through our unique Corporate Internship Program, twenty-eight companies currently employ all 121 students in full-time, entry-level, job-sharing positions. Our students are young professionals, earning more than half the cost of their education and experiencing the real world under the leadership of corporate role models. This unique approach to educating our young people has been proven to lower dropout rates and increase graduation and college attendance rates. Since our opening in September, our students are proving their capabilities. More than 90% of our students were ranked as "good" or "outstanding" by their corporate sponsors on their job performance. Students had a 98% attendance rate at their internships. And because of such outstanding performance, we expect that many of our corporate sponsors will renew their commitment and hire another team of students in the 2008-09 school year.

As this report reflects, many friends have helped to build a firm foundation for Cristo Rey Jesuit. Many generous benefactors believe in our mission of offering a quality Jesuit Catholic college preparatory education for young men and women of the city of Baltimore.

With your support we have been able to open our doors to 121 students this past fall, and put into place many of the essential services that are part of a college prep high school education. You are making their education possible.

In the name of our students, faculty and staff, I thank you for your commitment to the lives of the families we serve here at Cristo Rey Jesuit. In our foundational years, your generosity is helping to develop the school and build a bridge to the future for our students.

I hope that you will continue to walk with us in the future.

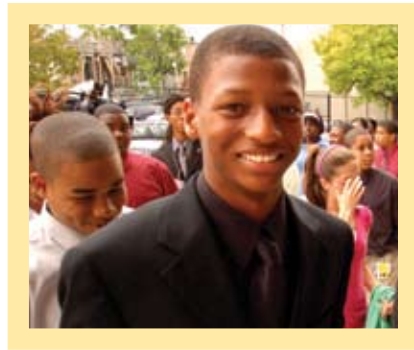

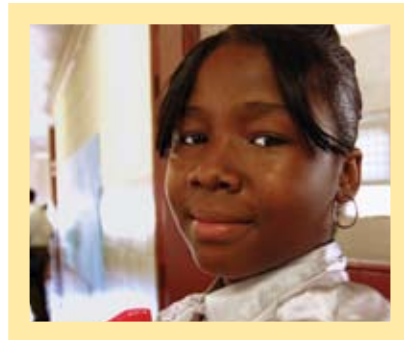
